Thank you for the inquiry dated Apr. 23, 2003.

You are not required to file form 940 because you have been determine to be an exempt organization under section 501(c)(5) of the Internal Revenue Code; therefore, you are exempt from paying Federal unemployment tax. Please destroy any form 940 returns you may have received. Do not make tax deposits for Fgderal unemployment tax.

We will send you a refund for your payments for the current year. You may request refunds for payments made in previous years by filing a form 843 claim. You must file a claim for refund within three years from the return due date, or within two years from the date you paid the tax, whichever is later.

Even though you are not liable for the Federal tax, you could be liable for the state tax. States establish and operate their own systems. Therefore, you should contact your state to find out whether you are required to make contributions under the state unemployment compensation law.

Dear Sir/Madam:

Congratulations! Your application for exemption from New Jersey sales and use has been approved. An Exempt Organization Certificate (Form ST-5) is enclosed. retain this unsigned original as part of your permanent records and make as many as needed to give to vendors for proof of exempt purchases.

The ST-5 exemption certificate grants your organization exemption from New Jers and use tax on the organization's purchases of goods, meals, services, room occupied admissions that are directly related to the purposes of the organization, except purposes of energy and utility services. Also, your organization is exempt from collecting said occasional fundraising sales (except sales of motor vehicles) and on sales of donate made from a store in which at least 75% of the merchandise is donated and 75% of workers are volunteers.

Please note that this exemption does not apply to regular (on-going) sales of taxas goods, meals, beverages and services. If your organization operates a catering but restaurant, bar or similar business, or is a store or mail-order business, you must co sales tax on taxable goods such as prepared foods, beverages, alcoholic and soft d cigarettes and cigars.
